Petitioner is not changing Applicant's name to that of another individual for the purpose of committing or furthering the commission of any offense under title 13, chapter 18, 20, 21, 22, 23 or 27, Arizona Revised Statutes, or any other offense involving false statements.

This Petition is made solely for Applicant's best interests and will not operate to release Applicant or Petitioner from any obligations Applicant or Petitioner has incurred or is under, or to defeat or destroy any rights of property, or action had in Applicant's original name.

THEREFORE, Petitioner asks that the Court enter an order that Applicant's present name of **child's current legal name** be changed to **child's new legal name**.
