Part III - Statement of Program Service Accomplishments: SAGA directly serves about 500 people; indirectly about 1,500 people. During the year of 2019, SAGA has maintained its 5 life-saving support groups that meet monthly in a separate studio from our office that we rent out. These 5 support groups are: Desert Sisters, Dezert Boyz, Gender Outlawz, General SAGA Meeting, and Families Transformed. These services provide a space for transgender and gender non-conforming Tucsonians to ask questions they don't feel comfortable asking elsewhere, provide resource information, and make community with folx that have shared-struggles. The Families Transformed group also provides cis parents with educational tools so that they may be better equipt to advocate for their trans children.
